

The Aspire, Believe and Achieve Scholarship (ABA Scholarship) is awarded to select high school students who enroll in Trident courses for the purpose of furthering the recipients' education. This scholarship covers 100% of the tuition for the following courses:

1. COM 100 Communicating for Success – 1 semester credit
2. FIN 100 Financial Literacy – 1 semester credit
3. PSY 100 Psychology of Success – 1 semester credit

To qualify for the ABA Scholarship, students must have completed their sophomore year of high school, have a cumulative GPA of 3.0 or higher, and complete the online Trident application for undergraduate admissions. To remain eligible, students must receive a grade of D or higher in the completed Trident courses listed above. If approved for the ABA Scholarship, a student's account will be adjusted accordingly by the Trident Financial Billing Office. The ABA Scholarship applies to non-degree seeking high school students only and can be used for the first attempt of each course; the scholarship does not apply to repeated courses. If the student withdraws from a course, there is no refund. High school students under the age of 18 must have parental consent.

Agreement

1. I have read and understand the ABA Scholarship terms and conditions and accept this scholarship. I understand that the scholarship award applies to tuition only and cannot be paid or refunded to me.
2. I attest that I have currently have a cumulative high school GPA of 3.0 or higher (weighted or unweighted). If this attestation is found to be false or untrue, I understand that I will not have met a Trident admissions requirement, will be subject to immediate dismissal from Trident, and may be required to pay back any ABA Scholarship funds which were applied to my account.
3. Any courses in which I enroll will appear on my official Trident transcript. Trident does not imply, promise, or guarantee that any credits earned at Trident will be transferable or accepted by any other institution. It is my obligation to ascertain in advance of enrollment whether a possible recipient institution will recognize a course of study or accept credits earned at Trident.
4. I am responsible for complying with all policies and procedures, including Trident's Code of Conduct.
